Phytol and sitosterol, isolated from methanolic extract of Lacistema pubescens, may have antileishmanial and cytotoxicity activities. [1]

E-phytol and beta-damascenone have antispasmodic activity.

E)-phytol has antimycobacterial activity against Mycobacterium tuberculosis with a minimum inhibitory concentration (MIC) of 2 micrograms/ml. [3]

Phytol has been identified as a peroxisome proliferator-activated receptor (PPAR)alpha- specific activator, phytol can stimulate the expression of PPARalpha-target genes in intact cells, because PPARalpha activation enhances circulating lipid clearance, phytol may be important in managing abnormalities in lipid metabolism [4]
