BIOLOGICAL ACTIVITY OR INHIBITORS

Deoxypodophyllotoxin(DOP), isolated from Juniperus sabina L, shows strong insecticidal activity against several kinds of insects, including the 5th instar larvae of silkworm, B. mori; and related lignans against larvae of Pieris rapae L. [1,2]

Deoxypodophyllotoxin induces G2 /M cell-cycle arrest followed by apoptosis through multiple cellular processes, involving the activation of ATM, upregulation of p53 and Bax, activation of caspase-3 and -7, and accumulation of PTEN resulting in the inhibition of the Akt pathway. [3]

Deoxypodophyllotoxin is a natural product, isolated from a variety of medicinal herb plants, has antitumor, antiviral, and anti-inflammatory activities; it inhibits both TTX-S (tetrodotoxin-sensitive) and TTX-R (tetrodotoxin-resistant) sodium currents in voltage clamp recording and caused a decrease in the number of action potentials (APs) in current clamp experiment; suppressive and unfavorable effects of DOP on the kinetics of sodium currents in terms of excitability of DRG neurons may greatly contribute to its antitumor and anti-inflammatory activities. Deoxypodophyllotoxin has PCA inhibitory activity, is stronger than those of prednisolone and indomethacin, suggest that it may be beneficial in regulating the immediate-type allergic reaction. [5]

Deoxypodophyllotoxin exerts both anti-angiogenic and vascular disrupting effects. Deoxypodophyllotoxin inhibits the expression of intercellular adhesion molecule-1 induced [7]

Deoxypodophyllotoxin decreases the mRNA levels of the Th2 cytokines, also reduces by tumor necrosis factor-alpha in murine lung epithelial cells.

[8] Deoxypodophyllotoxin decreases UV-induced skin pigmentation of brown guinea pigs, both the eotaxin and arginase I mRNA levels in a dose-dependent manner. suggests that it maybe applicable to treat hyperpigmentation [9]
