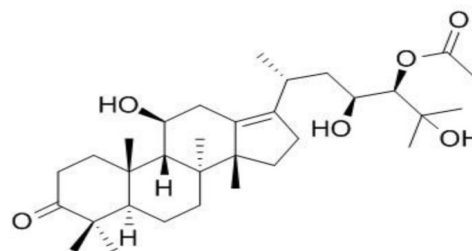

BIOLOGICAL ACTIVITY OR INHIBITORS

Alisol A 24-acetate, isolated from the rhizome of *Alismatis plantago-aquaticae* L. var. *orientale* Samuelson (Alismataceae), has anti-complement activity against the classical pathway of the complement system with IC50 values of 130 microM. [1]

Alisol A 24-acetate can effectively prevent bone loss in ovariectomized (OVX) mice, and that it can be considered a potential therapeutic for the treatment of postmenopausal osteoporosis. [2]

Alisol A-24-monoacetate has hypocholesterolemic effect. [3]

Alisol A 24-acetate can inhibit RANKL-mediated osteoclast differentiation by downregulating NFATc1, which plays an essential role in osteoclast differentiation; it also inhibits the expression of DC-STAMP and cathepsin K, which are related to cell-cell fusion of osteoclasts and bone resorption, respectively, therefore, alisol A 24-acetate could be developed as a new structural scaffold for inhibitors of osteoclast differentiation in order to develop new drugs against osteoporosis. 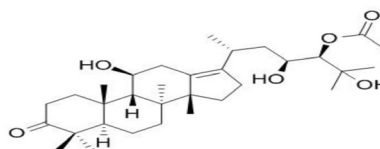
