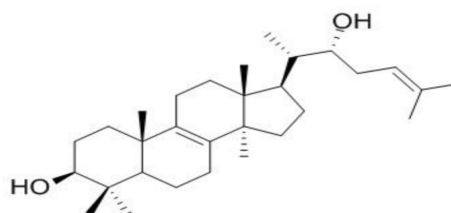

BIOLOGICAL ACTIVITY OR INHIBITORS

Inotodiol, a lanostane-type triterpenoid was isolated from the sclerotia of *Inonotus obliquus*, exhibits the potent anti-tumor promoting activity in the in vivo carcinogenesis test [1]
Inotodiol inhibits cell proliferation through apoptosis induction by activating caspase-3. [2]
Inotodiol has anti-inflammatory activities, it can inhibit significantly ear edema in mice produced by xylene at 10 mg/kg and reduce remarkably vascular permeability at 10 mg/kg
Inotodiol has antimutagenic and antioxidative activities. [4]

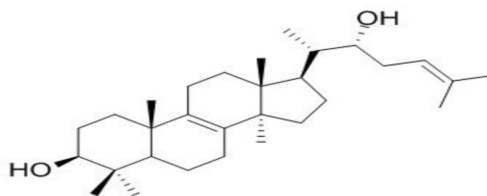
