**BIOLOGICAL ACTIVITY OR INHIBITORS** 

Chikusetsusaponin IVa, isolated from the whole plant of Alternanthera philoxeroides (Mart.) Griseb (Amaranthaceae), it shows antiviral activities against HSV-1, HSV-2, human cytomegalovirus, measles virus, and mumps virus with selectivity indices (CC (50)/IC (50)) of 29, 30, 73, 25, and 25, respectively; it also provides in vivo efficacy in a mouse model of genital herpes caused by HSV-2; demonstrate that chikusetsusaponin IVa may be a candidate of antiherpetic agents. [1]

Chikusetsusaponin IVa can inhibit thrombus formation in a stasis model of venous thrombosis, although it does not induce a significant bleeding effect; it also prolongs the ex vivo activated partial thromboplastin time, suggests that chikusetsusaponin IVa exerts antithrombotic effects, including minor hemorrhagic events.. [2] Chikusetsusaponin IVa has anti-inflammatory effects, it suppresses the production of inducible nitric oxide synthase (iNOS), cyclooxygenase-2 (COX-2), interleukin-1 beta (IL-1 $\beta$ ), interleukin-6 (IL-6), and tumor necrosis factor-a (TNF-a) in LPS-stimulated THP-1 cells likely by inhibiting NF- $\kappa$ B activation and ERK, JNK, and p38 signal pathway phosphorylation.[3] Chikusetsusaponin IVa has immunomodulating activity, it increases splenocyte proliferation in dose-dependent manner and at a concentration of 25  $\mu$ g/ml the compound [4] Chikusetsusaponin IVa has hepatoprotective activity.
