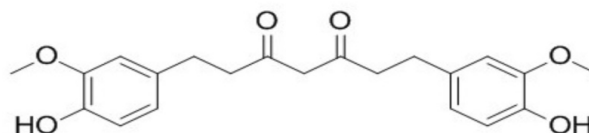

BIOLOGICAL ACTIVITY OR INHIBITORS

Tetrahydrocurcumin (THC), one of the major metabolites of curcumin, has antioxidative activity, it has inhibitory effects on the lipid peroxidation of erythrocyte membrane ghosts [1]

Tetrahydrocurcumin exhibits variable anti-inflammatory and anti-proliferative activities, which does not correlate with its ability to modulate the ROS status. [2]

Tetrahydrocurcumin can ameliorate oxidative stress-induced renal injury in mice. [3]

Tetrahydrocurcumin, curcumin and dihydroxytetrahydrocurcumin exhibit significant inhibitory effects on 12-O-tetradecanoylphorbol-13-acetate (TPA)-induced O₂-generation [4]

Tetrahydrocurcumin has protective action against chloroquine or erythromycin estolate-induced hepatotoxicity. [5,6]

Tetrahydrocurcumin expresses its anti-angiogenesis without any cytotoxic activities to HepG2 cells even at the highest doses, suggests that anti-angiogenic properties [7]

Combination of tetrahydrocurcumin and chlorogenic acid can potentially ameliorate lipid [8]

Tetrahydrocurcumin and rutin have cardioprotective effect on lipid peroxides and antioxidants in experimentally induced myocardial infarction in rats. [9]

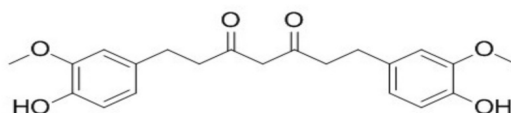
