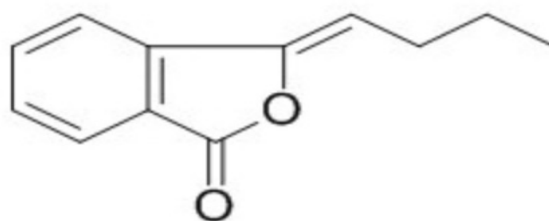

BIOLOGICAL ACTIVITY OR INHIBITORS

3-(Z)-butylidenephthalide shows antihyperglycemic activity, it (56.2 mg/kg) decreases blood glucose levels in NAD-STZ-diabetic mice after an oral sucrose load, suggesting that its antihyperglycemic effect is due to inhibition of α -glucosidase at the intestinal level; it also inhibits the activity of yeast- α -glucosidase (IC₅₀ 2.35 mM) in a noncompetitive fashion with a K_i of 4.86 mM. (Z)-Butylidenephthalide(Bdph)

can restore temozolomide sensitivity to temozolomide-resistant malignant glioma cells by downregulating expression of the DNA repair enzyme MGMT. [2]

(Z)-Butylidenephthalide was reported to more potently inhibit electrically induced twitch responses than acetylcholine-induced tonic contraction in isolated guinea-pig ileum (GPI). [3]

(Z)-Butylidenephthalide has antitumor effects, because of the limitation of the blood-brain barrier, the Bdph dosage required for treatment of glioma is relatively high; a local-release system with Bdph incorporated into a biodegradable polyanhydride material, p(CPP-SA; Bdph-Wafer) can deliver a sufficient concentration of Bdph to the tumor site and effectively inhibit the tumor growth in the glioma. 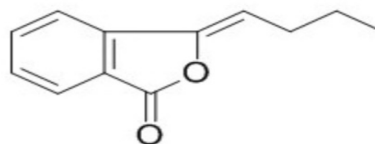
