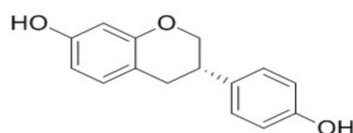

BIOLOGICAL ACTIVITY OR INHIBITORS

Equol is a nonsteroidal estrogen metabolized from the soy isoflavone daidzein by intestinal bacteria, it plays various biological roles in cancer, osteoporosis, and cardiovascular disease; equol inhibits the odorant-induced signaling pathway through modulation of PKA/CREB signaling transduction. [1]
Dietary soy isoflavones (such as equol) are neuroprotective in transient focal cerebral ischemia in male and OVX female rats, they may protect the brain via increases [2]
R-(+)-equol and S-(-)-equol inhibit the invasion of MDA-MB-231 breast cancer cells potentially via the down-regulation of matrix metalloproteinase-2. [3]

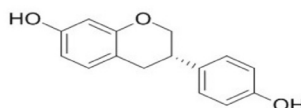
