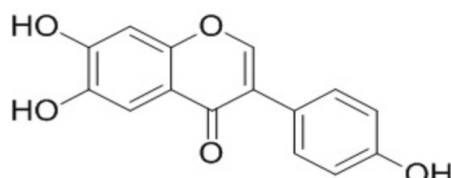

BIOLOGICAL ACTIVITY OR INHIBITORS

6,7,4'-Trihydroxyisoflavone shows inhibitory activity against monophenolase activity of mushroom tyrosinase , with IC 50 values of 0.009 ± 0.001 mM. [1]

6,7,4'-Trihydroxyisoflavone bound directly to cyclin-dependent kinase (CDK)1 and CDK2 in vivo, resulting in the suppression of CDK1 and CDK2 activity in tumors, it significantly decreased tumor growth, volume and weight of HCT-116 xenografts in a xenograft mouse model; suggests that CDK1 and CDK2 are potential molecular targets of 6,7,4'-THIF [2]

6,7,4'-Trihydroxyisoflavone can suppress adipogenesis in 3T3-L1 preadipocytes via ATP-competitive inhibition of PI3K. [3]

6,7,4'-Trihydroxyisoflavone exhibits significant antistaphylococcal effects against various standard strains and clinical isolates, including methicillin and tetracycline resistant ones with the MICs ranging from 16 to 128 ug ml(-1). [4]

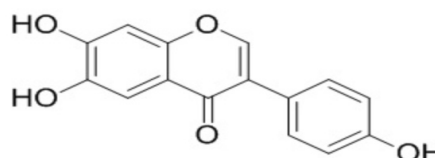
