BIOLOGICAL ACTIVITY OR INHIBITORS

Chlorogenic acid, a phenolic compound found ubiquitously in plants, is an in vitro antioxidant and metal chelator, some derivatives of chlorogenic acid are hypoglycemic agents and may affect lipid metabolism;in vivo, chlorogenic acid can improve glucose tolerance, decrease some plasma and liver lipids, and improve mineral pool distribution.[1] Chlorogenic acid and caffeic acid have antioxidant property, have effects on intestinal ischemia-reperfusion injury.[2]

Chlorogenic acid has antiviral activity, reduces serum DHBV level in DHBV-infected duckling model, shows inhibitory effect on HBV replication.[3]
